TREASURER'S REPORT: *Staff reporting:* Roze Wiebe gave an update on the un-audited Profit and Loss Statement, Balance Sheet, and Budget vs. Actual reports for the period ending in December 2021. Wiebe discussed proposed budget for 2022.

Motion was made by Ogden: seconded by Lamkins; to approve the 2022 proposed budget. Motion was carried unanimously.

Motion was made by Lamkins: seconded by Johnson; to approve the 2020 financial statements after reviewing the 2020 Audit documents. Motion was carried unanimously.

- **COMPLIANCE & IDEX:** *Staff Reporting:* Roze Wiebe gave a report on the various numbers of current, delinquent, and expired CIDs for the period ending December 2021. She also gave an update on the IDEX status for the same period.
- **MARKETING/OUTREACH:** *Brazil reporting:* George Brazil discussed CCIDC's marketing plan for 2022, which includes reviewing social media promoter, promotion of CCIDC's 30-year anniversary, rebranding, and possible sponsorship opportunities.
- **CORRESPONDENCE:** *Staff reporting:* Roze Wiebe discussed an article released by AIA staff discussing the diversifying of the profession and loosening opposition to interior design licensure. CCIDC welcomed guest speaker Mark Christian, AIA CA Director of Government Relations, to discuss this article in further detail.
- **CHAIR'S REPORT:** *Brazil Reporting:* George Brazil discussed what his goals are for CCIDC during his first term in office as chair.
- **UNFINISHED BUSINESS:** *Staff Reporting:* Roze Wiebe discussed where CCIDC is at during the sunset review process: the report has been submitted and now CCIDC is waiting for hearing date. Wiebe provided an IDEX Exam update regarding the revisions now being completed, how the first testing window went using the revised exam, and what the next steps are to determine the final cut score.
- **NEW BUSINESS:** *Brazil Reporting:* George Brazil discussed CCIDC's goal to introduce sponsorship opportunities in 2022.
- **STRATEGIC PLANNING:** *Staff Reporting:* Roze Wiebe discussed the need for more strategic planning meetings and explained what the objective of these meetings are. She discussed possible topics for the strategic planning meetings, such as financial planning, marketing, IDEX exam revision updates, sunset review, and future planning. Wiebe also presented candidates for two open board positions.
- NEW BOARD MEMBERS: *Brazil Reporting:* Introduction of the new Board Candidates Niloofar Rezvanpoor for the Public Member Position to fill the vacant position and Julissa Garcia for the IIDA Member Position to replace termed-out Eduardo Melgar. Ms. Rezvanpoor was not in attendance and Ms. Garcia was given the opportunity to speak to the Board about her background and interest in serving the CCIDC Board.
